AMENDMENT NO. 1 TO CONTRACT FOR AUTOMATED LICENSE PLATE READER SYSTEM

WHEREAS, the City of Cedar Rapids, Iowa ("the CITY") and Flock Group Inc. ("FLOCK") are parties to a Contract, whereby FLOCK provides the automated license plate readers system for the CITY; and

WHEREAS, the CITY and FLOCK are desirous of amending the Contract, authorized by Resolution No. 0823-06-24.

NOW, THEREFORE it is agreed by and between the CITY and FLOCK, as follows:

1. Due to the installation dates of the equipment the contract did not fully begin until November 1, 2024. Because of this, it is necessary to adjust the Contract end date to October 31, 2026. Any subsequent renewals will be November through October.
